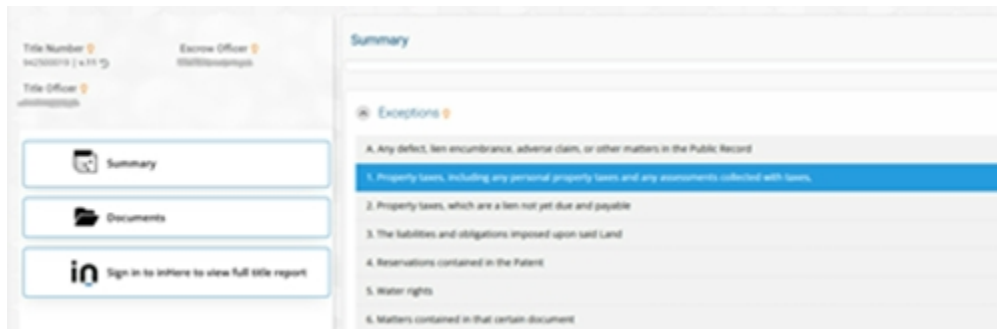

7. 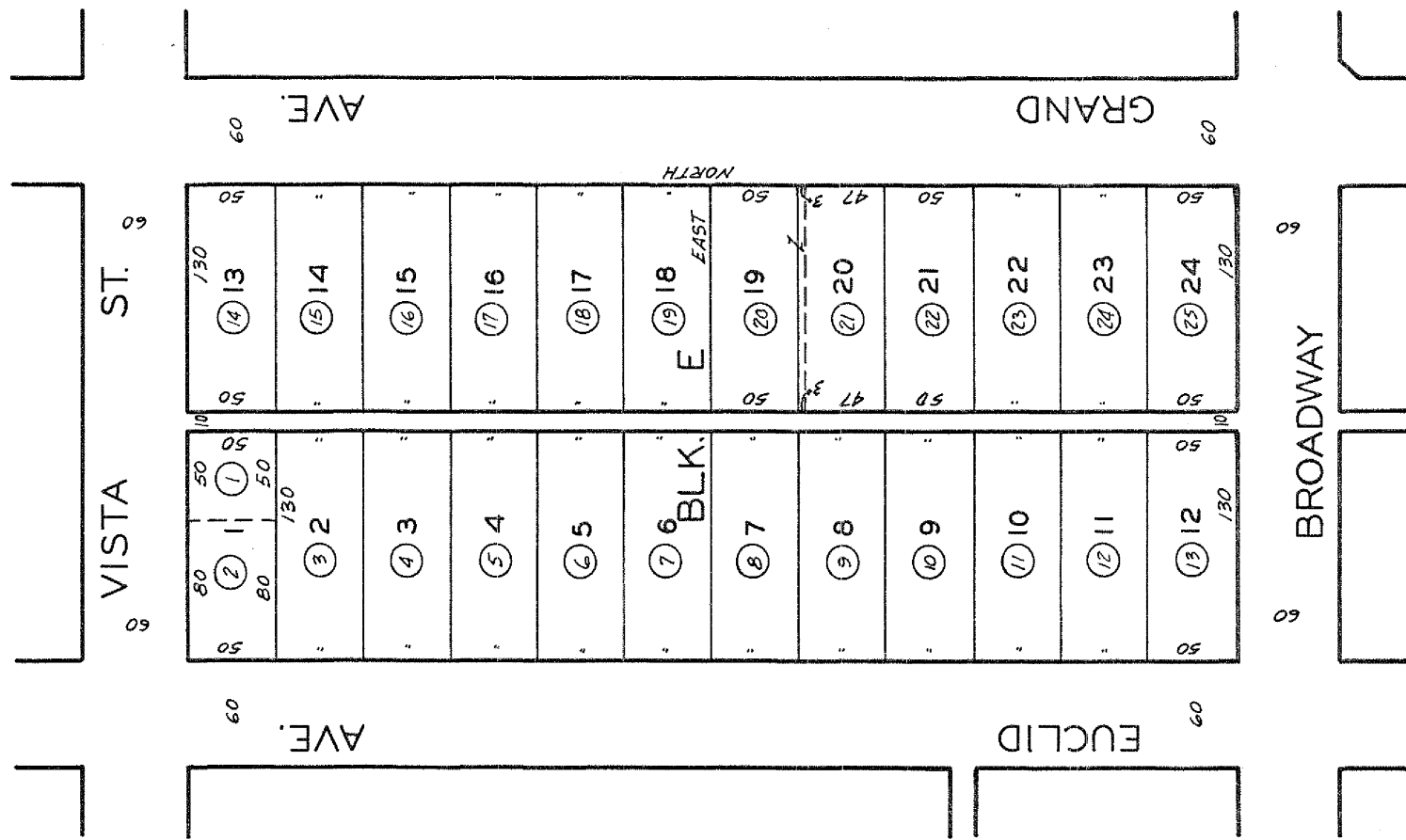
